

## **Directions from Biloxi Tennis Complex (765 Wells Dr, Biloxi 39532)**

### **Treasure Oak Country Club (2105 Bienville Blvd, Ocean Springs 39564)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 0.9 mi
4. Turn LEFT onto BIENVILLE BLVD / US-90 E. go 1.3 mi
5. Merge onto I-10 E. go 5.3 mi
6. Merge onto MS-609 S via EXIT 50 toward OCEAN SPRINGS / ST. MARTIN. go 3.0 mi

### **Singing River Yacht Club (3900 Beach Blvd Pascagoula 39567)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 0.9 mi
4. Merge onto I-10 E. go 24.5 mi
5. Take the MS-57 Exit, EXIT 57, and travel south to Hwy 90
6. Turn left on Hwy 90 and travel to Pascagoula
7. After crossing the high rise bridge into Pascagoula, travel about 2 miles and turn right on Chicot Road
8. Turn LEFT onto INGALLS AVE. go 0.1 mi
9. . Turn RIGHT onto MARTIN RD. go 0.9 mi
10. Turn LEFT onto BEACH BLVD. go 0.1 mi
11. 3900 BEACH BLVD is on the RIGHT. go 0.0 mi

### **Bayou Bluff Tennis Club (11553 West Taylor Road Gulfport 39503)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 1.0 mi
4. Merge onto I-10 W via the ramp on the LEFT toward NEW ORLEANS. go 6.0 mi
5. Take the MS-605 S exit, EXIT 38, toward GULFPORT / COWAN RD / BERNARD BAYOU INDS. DIST.. go 0.2 mi
6. Turn LEFT onto LORRAINE RD / MS-605 S. go 2.3 mi
7. Turn RIGHT onto E TAYLOR RD. Go Straight through stop sign, Bayou Bluff is on the LEFT

### **St Martin Tennis Courts (10800 Yellow Jacket Boulevard, St Martin 39532)**

1. Start out going NORTH on WELLS DR toward RICHARD DR
2. Turn RIGHT onto RICHARD DR
3. Turn LEFT onto CEDAR LAKE RD
4. Merge onto I-10 E
5. Merge onto MS-609 S / WASHINGTON AVE via EXIT 50 toward OCEAN SPRINGS / ST. MARTIN.
6. . Turn LEFT onto OLD FORT BAYOU RD
7. Turn RIGHT onto YELLOW JACKET RD
8. 10800 YELLOW JACKET RD is on the LEFT

### **Vancleave Tennis Courts (5400 Ballpark Road Vancleave 39565)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 0.9 mi
4. Merge onto I-10 E. go 13.1 mi
5. Take the MS-57 exit, EXIT 57, toward VANCLEAVE / GAUTIER. go 0.3 mi
6. Turn LEFT onto MS-57 N. go 6.2 mi
7. Turn LEFT onto BALLPARK RD. go 0.6 mi
8. 5400 BALLPARK RD is on the RIGHT.

## **Directions from Biloxi Tennis Complex (765 Wells Dr, Biloxi 39532)**

### **I.G. Levy Tennis Courts (3900 Chicot Street Pascagoula 39581)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 0.9 mi
4. Merge onto I-10 E. go 24.5 mi
5. Take the MS-57 Exit, EXIT 57, and travel south to Hwy 90
6. Turn left on Hwy 90 and travel to Pascagoula
7. After crossing the high rise bridge into Pascagoula, travel about 2 miles and turn right on Chicot Road
8. Travel .4 miles and courts are on the left

### **D'Iberville Tennis Courts (4240 Brodie Road D'Iberville 39540)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 m
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. RICHARD DR becomes BRODIE RD. go 1.4 mi
4. Stay Straight on Brodie Road until you come to D'Iberville Elementary School on your left. Driveway is on the left after the school. Courts are on your left.

### **Mississippi Gulf Coast Community College (2300 Highway 90, Gautier, MS 39553)**

1. Start out going NORTH on WELLS DR toward RICHARD DR.
2. Turn RIGHT onto RICHARD DR.
3. Turn LEFT onto CEDAR LAKE RD.
4. Merge onto I-10 E.
5. Take EXIT 61 toward GAUTIER
6. Merge onto GAUTIER VANCLEAVE RD / VAN CLEAVE RD
7. Turn LEFT onto US-90 E
8. 2300 HIGHWAY 90 is on the left

### **Halstead Tennis Center (401 Halstead Road Ocean Springs 39564)**

1. Start out going NORTH on WELLS DR toward RICHARD DR. go 0.2 mi
2. Turn RIGHT onto RICHARD DR. go 0.3 mi
3. Turn LEFT onto CEDAR LAKE RD. go 0.9 mi
4. Merge onto I-10 E. go 5.3 mi
5. Merge onto MS-609 S via EXIT 50 toward OCEAN SPRINGS / ST. MARTIN. go 3.0 mi
6. Turn LEFT onto BIENVILLE BLVD / US-90 E. go 1.3 mi
7. Turn RIGHT onto BECHTEL BLVD. go 0.2 mi
8. Turn LEFT onto GOVERNMENT ST. go 0.4 mi
9. Turn RIGHT onto HALSTEAD RD. go 0.6 mi
10. Courts will be on the right.
